MACED works with people in eastern Kentucky and Central Appalachia to create economic opportunity, strengthen democracy and support the sustainable use of natural resources.

MACED's Enterprise Development program helps entrepreneurs develop the tools and skills they need to create quality jobs through strong businesses that provide important community services. We provide access to capital and combine our investment capital with training and technical assistance to increase the capacity of entrepreneurs. At fiscal year end, the combined portfolio of MACED and its affiliated nonprofit Appalachian Investment Corporation included 190 loans totaling \$11,167,493. In fiscal year 2014 we closed 50 loans totaling \$2,297,360, resulting in the creation or retention of 74 jobs. Our staff and contractors provided 3,258 total hours of technical assistance.

4b (Code:) (Expenses \$ 331,422. including grants of \$ 112,552.) (Revenue \$ 1,811.)
The Forestry program provides private landowners with education, financial assistance to cover the costs of management activities, and new income options such as carbon offsets to incent sustainable forest management. At the close of fiscal year 2014, a total of 48 landowners representing 28,739 acres were enrolled. Another 20 landowners representing 17,170 acres were actively seeking enrollment. Since the beginning of the program, landowners have been paid \$197,659 and consulting foresters have earned \$534,818 from forest inventories.

4c (Code:) (Expenses \$ 468,164. including grants of \$ 371,400.) (Revenue \$)
The Central Appalachian Network (CAN) is composed of six nonprofits that promote environmentally sustainable community development in Central Appalachia. CAN's goals include strengthening Central Appalachia's healthy food sector through value chain development, increasing the capacity of CAN and CAN partners, and engaging in policy change that supports sustainable development in Central Appalachia. In fiscal year 2014, CAN built local food value chains primarily through educational conferences, technical assistance, and small grants. MACED serves as fiscal sponsor for CAN.

MACED's research and policy efforts seek to remove the barriers that hinder sustainable development strategies and to make government more effective in promoting development that works for people and places in need in Central Appalachia. The Kentucky Center for Economic Policy (KCEP) is a provider of solid information and grounded analysis about state fiscal and economic policy issues and their impact on low- and moderate-income Kentuckians. In fiscal year 2014, we produced research on immigration, Kentucky's tax system and state budget, need-based college aid, the minimum wage, re-entry for ex-offenders, an Appalachian planning and development fund and other issues. We operated an Appalachian transition communications effort as well as a KCEP blog that produced a stream of analysis and commentary on pressing issues facing the state and region. Our work was cited in 143 separate media stories, including appearances on a state-wide public affairs show and 10 opinion pieces in Kentucky newspapers.

How\$martKY

The How\$martKY program is a demonstration of a flexible investment structure that allows utility customers to pay for a portion of an efficiency upgrade each time they pay their utility bills, in effect paying for the retrofit out of the savings it produces. In fiscal year 2014, 23 homes received retrofits. On average, those homes are

projected to save 466 MMBtu, resulting in a savings of over \$650 per household per year.

Energy Efficient Enterprises

The Energy Efficient Enterprises project helps small businesses and enterprises reduce energy costs and consumption through increased energy efficiency. In fiscal year 2014 we facilitated 24 energy efficiency retrofits, resulting in an estimated 11,402 MMBtu of non-electric fuels saved in the first twelve months following these retrofits. Seven renewable energy projects were installed. A total of \$750,585 was invested in these 31 projects, resulting in an estimated \$515,383 saved.

General Community Development

Historically, MACED has provided administrative support services to and has maintained a joint employer relationship with several small nonprofits whose mission closely aligns with MACED's. Currently MACED provides these services to Kentucky Natural Lands Trust (KNLT). KNLT is a nonprofit conservation organization working to secure funds to protect natural lands and provide for their long-term stewardship. Expenses \$ 1,127,775. including grants of \$ 119,240. Revenue \$ 63,761.

considering the committee's report, the board sets the president's compensation for the following year. The board takes into account compensation levels reported on Forms 990 for the CEOs of three to five comparable organizations as well as its knowledge of compensation of positions in the private and nonprofit sectors with comparable levels of responsibility, qualifications and achievement. The president does not participate in or vote on the decision on the president's compensation. The board's decision on compensation is recorded in minutes which are presented and approved at the following board meeting. This process last took place in December 2013.

The president determines the compensation of other staff, including those who serve as corporate officers, following an annual performance review of each staff member. Along with considerations of equity among staff, the president takes into account compensation levels reported on Forms 990 for officer positions in three to five comparable organizations and his knowledge of compensation of positions in the private and nonprofit sectors with comparable levels of responsibility, qualifications and achievement. Every change in a staff salary is documented in a letter to the staff member.
